Item 1. Introduction

ProAthlete Wealth Management LLC ("PAWM") is an investment adviser registered with the U.S. Securities and Exchange Commission. Investment advisory and brokerage services and fees differ; therefore, it is important for you to understand the differences. # "What investment services and advice can you provide me?"

## Description of Services and Monitoring

We provide investment advisory services to retail investors, including portfolio management and financial planning, consulting, and concierge services (collectively, Concierge Services). For clients to whom we provide these services, we offer a fee plus transaction accounts, which we monitor as part of an ongoing process. PAWM does not offer or sponsor a wrap fee product. These services provide portfolio accounting, performance analysis and access to a universe of third-party money managers. Third-party money managers receive separate fees for the services they provide. As part of our standard services, each IAR reviews their client accounts regularly and meets with clients at their request. Factors that trigger reviews include changes to investment recommendations, market conditions, or your financial situation and/or investment needs.

## Investment Authority

We offer our portfolio management accounts on a discretionary basis. Discretionary asset management allows us the limited authority to buy and sell investments in your account without asking you each time a transaction is placed. Our level of authority is determined at the beginning of our relationship with you in our advisory agreement but can be changed upon request.

## Investment Offerings and Account Minimums

While we can advise on any investment asset, our investment recommendations are primarily related to investments in equities, ETFs, bonds, and mutual funds. PAWM's recommended minimum account size is \$500,000. However, PAWM maintains discretion to waive any account minimums

Item 3. Fees, Costs, Conflicts, and Standard of Conduct

## "What fees will I pay?"

Our fee covers the services provided through our Concierge Services. We charge an ongoing asset-based fee at the end of each quarter. The fee is charged as a percentage of your assets that we manage. The more assets there are in your advisory account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account.

Clients pay an ongoing asset-based fee at the end of each quarter.

Other Fees and Costs: Some investments, such as mutual funds and ETFs, impose additional fees that will reduce the value of your investments over time. Those fees may include fund expenses and surrender charges. You may also pay other fees to the custodian of your assets. These include, but may not be limited to, ticket charges on transactions, fees for wire transfers, stop payments, IRA maintenance, duplicate check or statement copies, overnight deliveries, returned checks, and asset transfers.

# "What are your legal obligations to me when acting as my investment adviser?" "How else does your firm make money and what conflicts of interest do you have?"

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

For example, many of our IARs are also registered representatives of a broker-dealer or insurance agents licensed with an insurance company. Through the broker-dealer and/or insurance company, our IARs can offer commission-based products for which they receive additional compensation. In addition, PAWM has received transition assistance renumeration to move its custodial business to Charles Schwab & Co. Inc. ("Schwab"). This additional compensation causes a conflict of interest as our IARs have an incentive to solicit commission-based products and PAWM has an incentive to utilize Schwab for custodial services.

## "How do your financial professionals make money?"

Our IARs are primarily compensated through salaries and/or a portion of revenue we receive for the advisory services we provide. The portion paid to your IAR generally does not vary based on the type of investments that are recommended. However, several of our IARs are also registered representatives of a broker-dealer and some are also insurance agents. When acting in these capacities, they will earn commissions.
